Founded in 2023 by registered occupational health nurse and instructor Stephanie McLean, Sauk Valley CPR, LLC is a mobile business based in Sterling, IL which provides services in the surrounding Sauk Valley communities. She first started teaching CPR in 2020 to the local business community when she worked at KSB Hospital. "I became an instructor because I was inspired by the stories of patients I've encountered over the years who survived cardiac arrest through CPR and I strongly support the American Heart Association's mission to provide science-driven education to those with a desire to learn and want to make a difference in a life-threatening emergency. More importantly, I want those I teach by the end of class to feel comfortable in their knowledge and skills so that there is no hesitation or reservations when immediate help is needed after 911 is called. So many of us are fearful of the consequences of doing CPR: 'Will I hurt or kill them?', 'Will I be held legally responsible if something goes wrong?' " They are all valid concerns but we work through this through video-led instruction and practice on the mannequins in a safe atmosphere which encourages questions, learning from mistakes, and utilizing constructive feedback. My belief is that the more people out there who know how to provide high-quality CPR, the better off we all are as a community. It's a good feeling to know that with every class I teach, there's more people added out there who've got your back if something should ever happen to you."

Sauk Valley CPR, LLC also provides instruction and certification in First Aid as well as training for businesses who must meet OSHA standards for blood borne pathogen prevention and exposures in the workplace. "Our business has a far-reaching audience and has the ability to meet many needs from day care centers, to churches, social groups, schools, businesses and factories – even individuals...you name it, I will do my best to try to accommodate what you need to accomplish your goals."

Increases to Exempt Salary Requirements are Coming – Get Ready!

On April 23, 2024, the United States Department of Labor (DOL) announced its final rule, amending the minimum salary levels necessary for employees to be considered exempt from the overtime requirements under the Fair Labor Standards Act (FLSA) “White Collar” (executive, administrative, and professional) exemptions. The final rule is set to take effect on July 1, 2024. The current minimum salary level threshold for exempt employees under the FLSA is \$684/week (\$35,568 annually) and \$107,432 minimum compensation for the highly compensated employee. The final rule does not amend the FLSA’s definition and standards related to an employee’s job duties under the “White Collar” exemptions.

The DOL’s final rule establishes the following changes:

Effective July 1, 2024,

Exempt employees must be paid a salary of at least \$844/week (\$43,888 annually). If employees make less than that amount, they are not exempt from overtime and are eligible to receive overtime for all hours worked in excess of 40 hours per week. Total compensation for the FLSA highly compensated exemption increases to \$132,964.

Effective January 1, 2025

The exempt salary threshold amount increases again to \$1,128/week (\$58,656 annually). Total compensation for the FLSA highly compensated exemption increases to \$151,164.

According to the final rule, the DOL will update these minimum salary thresholds every three years (i.e., on July 1, 2027, July 1, 2030, July 1, 2033) to reflect current earnings data.

It is critical for employers to review their current exempt employee pay mechanisms in light of the FLSA salary increases, and to analyze the following:

- How many of your current employees will be impacted by this salary increase?
- Is a salary increase in July 2024 and January 2025 for those who do not currently meet the salary requirement a plausible financial decision to meet the required increases?
- Are there job positions that should now be reclassified as non-exempt and the employees will now be entitled to overtime if they work over 40 hours?
- Tightening up policies regarding working overtime and working with management to limit the number of overtime hours worked for non-exempt employees.
- Reviewing job descriptions.
- Reviewing handbooks and policies regarding exempt and non-exempt status.
- Reviewing benefits applicable to exempt and non-exempt employees and how a change in status may impact the benefits to your employees.

Employers have options:

- Increase the employee’s salary to that proposed in the new regulations (July 1, 2024 and then again January 1, 2025);
- Keep the salary the same, reclassify the employee as non-exempt and pay the required overtime payments based on the employee’s regular rate of pay;
- Reclassify the employee as non-exempt and reduce the employee’s salary or change the employee to hourly at a lower rate so the total earnings do not change after overtime is paid;
- Eliminate the employee working any overtime hours

It is imperative for employers to analyze their exempt workforce NOW to prepare for the July 1, 2024 effective date.


